IMPORTANT: VISA FOR RUSSIA MUST BE REGISTERED WITHIN SEVEN DAYS UPON ARRIVAL IN RUSSIA. THIS IS THE TRAVELER'S RESPONSIBILITY TO COMPLY WITH THIS LAW STATED BY THE RUSSIAN GOVERNMENT.

The following are the requirements for U.S. or E.U. citizen to obtain business visa support for Russia. Visa support is a required document for obtaining business visa to Russia.

1. Clear scanned copy of the photo/information page from your passport emailed to info@milehighvisas.com.
2. Clear scanned copy of all previous Russian visa(s) in current passport emailed to info@milehighvisas.com. Please note that the copies must be legible or we will not be able to obtain the invitation for you.
3. Completed Request Form for Business Visa Support for Russia. All items on the form must be completed in full, giving particular attention to your entry and exit dates into and out of Russia. Incomplete request forms may delay the processing time.
